ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD AND DRAINAGE INVENTORIES, SPECIFICALLY GRANDE MAISON PH. 3B (WARD 4, DISTRICT 5) COUNCIL SERIES RES. NO.: C-6893

WHEREAS, Developer/Owner(s) have dedicated the rights or ways to the public as indicate on the finalized subdivision plat recorded in the Clerk of Court’s office; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that all the area within the right-of-way, the road base, drainage ditches, culverts, laterals, canals and appurtenances belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolution/Ordinance stated shall be incorporated in the Parish Maintenance System.

BE IT FURTHER ORDAINED: that all parish regulations, policies, procedure, and operating methods pertain to the Parish Maintenance System shall apply to the aforementioned developments:

Streets to be accepted into the maintenance system are named:

Chateau Papillon (R04E273) continues 409 feet from existing phase line for a total of approximately 894 feet

Chateau Fleuri (R04E276) approximately 768 feet
