# SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE

#### Removal of Transition Surface Obstructions West Side

Scope: Project to include design, environmental services, and grant administration for the Removal of Transition Surface obstructions West Side. Presently the airport fence line is approximately 160 feet from the runway centerline with 60 feet and taller pine trees at the fence line. The trees are a transition surface obstruction. Project is crucial to Airport runway safety and will be completed to FAA and LADOTD standards.

Status: The project is broken out into 2 phases: Phase 1 Engineering and Environmental and Phase II Construction. Parish has executed a task order with Digital Engineering contract for them to complete the design of the removal of the obstructions on the west side of the airport.
