Scope: Jail water heaters are over 10 years old and are in need of frequent repair. Replacing the jail hot water heaters will greatly improve inmate health and moral without disruption of hot water for showering and cleaning areas when a heater is down for repairs.

Status: Project has gone out to bid, with lowest bid over budget. Project expected to begin in early 2025.
