LA22 WWTP

Scope: The LA22 Wastewater Treatment Plant (WWTP) requires structural and mechanical modifications to extend the service life of the wastewater treatment plant. This 0.5MGD wastewater plant services multiple subdivisions, businesses, apartment complexes, etc. along LA22 from the Tchefuncte River toward Mandeville.

Status: The Department of Utilities had an engineering consultant evaluate the condition of the wastewater treatment plant and provide an opinion of probable construction costs.
