SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

CAPITAL PROJECTS - 254 - DISASTER RELIEF

Dixie Ranch Rd. Drainage-Hurricane Ida

Scope: The culverts under the intersection of Dixie Ranch Road and Hwy 190 were damaged during Hurricane Ida. The damaged culverts will be removed and replaced with larger culverts to increase the capacity of water flow to improve drainage.

Status: It is anticipated that Dixie Ranch Road Drainage design will be complete and ready to bid when funding is approved. Construction is anticipated to be completed early to mid-December.
