Lake Pontchartrain Barrier

Scope: Hire a consultant to perform a hydrodynamic modeling to evaluate the benefits and impacts of the Lake Pontchartrain Barrier project. Tasks include data gap analysis/modeling, framework development, and survey work.

This Study will build off of the Louisiana Coastal Protection and Restoration Authority's (CPRA) previous 2017 Coastal Master Plan to investigate the potential benefits of flood damage reduction and damaging effects to both Louisiana and Mississippi from a proposed barrier across the mouth of Lake Pontchartrain in southeast Louisiana across Chef Menteur Pass and the Rigolets.

Status: Timeframe for completion of construction will be approximately two years from the Notice to Proceed.
