#### Maison Du Lac Common SFM

Scope: This project is to install a sewer force main (SFM) that will bypass three lift stations in Maison du Lac that re-pump wastewater, which will improve quality of sewer service as well as reduce the number of sewer spills.

Status: This project is anticipated to be designed and constructed in 2024.

#### Medcath/Tamanend Water Distribution

Scope: Provide design of an interconnection of the Medcath water system and the Tamanend water system to provide the Medcath water system a secondary source as required by LDH. A water main will be installed along LA Highway 434 between the water systems to combine them into a single water system.

Status: This project is anticipated to be designed in 2024. Estimated construction cost of \$4,110,000.00 will need to be funded after design.
