ORDINANCE TO REMOVE ROAD AND LATERAL IN DISTRICT 6 THAT HAS NOT BEEN MAINTAINED BY PARISH FORCES, SPECIFICALLY BRELAND RD. (R05B007) AND BRELAND LANE DITCH (D05BW01007) (WARD 5, DISTRICT 6)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically for the corrections/additions/deletions to the road and drainage inventories based upon the recommendations of the Department of Engineering, Director of Public Works, 911 Facilitator.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System is amended as follows:

1. Remove Breland Rd. (R05B007) never maintained and private
2. Remove Breland Lane ditch (D05BW01007) never maintained

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
