Transfer grant funds to Capital Projects Fund 211 - Capital-Public Health for the Safe Haven Quad F/Cafeteria Building project.

Grant award received for urban transit operations. Award includes \$600,000 for preventative maintenance with a 20% match of \$150,000, \$1,630,895 for operations with a 50% match of \$1,630,895, and \$2,609,431 for capital with a 20% match of \$652,358, for a total award of \$4,840,326 with a match of \$2,433,253. Match will provided by COAST millage, program income, and LA DOTD Mass Transit Part B funds.
