ORDINANCE TO AMEND THE 2025 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 15  
DEVELOPMENT CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

WHEREAS, the Parish has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2025.

AMENDMENT NO. 15 - 2025 CAPITAL IMPROVEMENTS - JUNE 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Fishing Pier Boat Launch & Recreation Area

Scope: Development of a multi-functional coastal access and shoreline resilience facility adjacent to the St. Tammany Fishing Pier in Slidell, Louisiana.

Status: Construction duration is estimated at 9–12 months, post-construction operations and maintenance will be performed by the St. Tammany Parish Department of Public Works.

Fontainebleau Park Coastal Plan

Scope: Planning, design, and implementation of coastal restoration and resiliency measures within Fontainebleau State Park. The project goal is expected to provide environmental benefits by addressing the shoreline erosion that is occurring at the park as well as preventing further shoreline breeches.

Status: Timeline will be through spring of 2026.

Koop Dr. Trace Trailhead & Park

Scope: Provide engineering and landscape design services for improvements to the Koop Dr. Complex including a Tammany Trace Trailhead and Recreation Area, assuring it positively interacts with the community and the environment; functions as a community park that emphasizes green development and water management; is environmentally and economically sustainable; and provides features that attract more users and events to fully utilize the park. The master plan for the park is nearing completion and design services are required for implementation and potential grant funding.

Status: Working with the Department of Culture, Recreation and Tourism of the Louisiana Office of State Parks, St. Tammany Parish has an opportunity to utilize funding for construction. However, the National Park Service no longer accepts “conceptual level designs” on grant applications, so full engineering design must be complete for a full application. The Office of State Parks will accept the master plan (nearing completion) for pre-review submittal to no later than August 2025 and full application in Fall for potential construction funding in Spring 2026.

Anticipated timeframe is nine months.

St. Tammany LDCD Business Plan

Scope: This project will streamline coastal governance, boost efficiency, and improve coordination of services. It broadens access to funding, enhances transparency, and builds public trust. By strengthening storm resilience and planning for the long term, it supports sustainable infrastructure and better protection for the community.

Based on the current master plan of proposed structural infrastructure, the following will be developed based on future implementation of the proposed structural program:

- An organizational chart with classification of employees and titles
- A synopsis of operations/maintenance, emergency response services, and executive/financial management responsibilities
- Budget and financial projection for administrative, operations, maintenance, and capital program short- and long-term costs to determine a conceptual annual revenue draft of potential funding sources
