Then, South 89 degrees 18 minutes 52 seconds West a distance of 22.00 feet to a point;  
Then, South 00 degrees 41 minutes 08 seconds East a distance of 277.58 feet to a point, said point being the "POINT OF BEGINNING" and labeled "P.O.B.;"

Then, North 90 degrees 00 minutes 00 seconds East a distance of 64.72 feet to a point;  
Then, South 00 degrees 48 minutes 22 seconds East a distance of 20.00 feet to a point;  
Then, South 90 degrees 00 minutes 00 seconds West a distance of 64.75 feet to a point;  
Then, North 00 degrees 41 minutes 08 seconds West a distance of 20.00 feet to the "POINT OF BEGINNING".

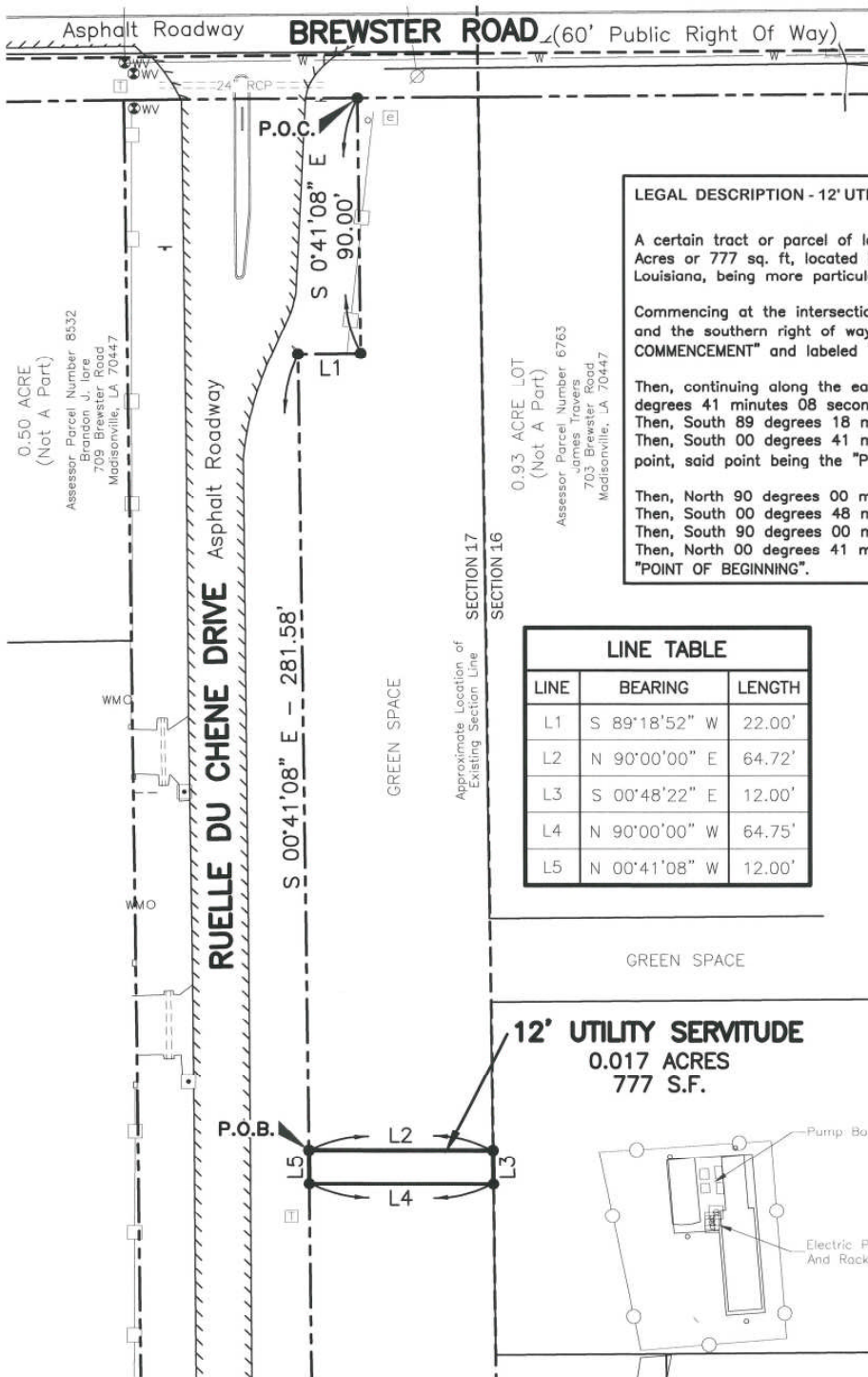

Then, South 00 degrees 41 minutes 08 seconds East a distance of 281.58 feet to a point, said point being the "POINT OF BEGINNING" and labeled "P.O.B.;"

Then, North 90 degrees 00 minutes 00 seconds East a distance of 64.72 feet to a point;  
Then, South 00 degrees 48 minutes 22 seconds East a distance of 12.00 feet to a point;
