The Parish President is hereby authorized to submit a pre-application, application, and issue debt in the maximum amount of \$706,825.00 to DEQ on behalf of the Parish for the purpose of placing this project on the Project Priority List for funding through the Clean Water State Revolving Fund loan program.
- SECTION 2. The Parish President is further authorized to furnish such additional information as may reasonably be requested in connection with the application materials.
- SECTION 3. The Parish President is hereby designated as the Official Project Representative for the Parish for any project that may result from the submission of such materials to DEQ.
- SECTION 4. Any materials previously submitted to the Department on behalf of the Parish are hereby ratified and approved.
