OF THE PARISH OF ST. TAMMANY, STATE OF LOUISIANA, TO  
SUBMIT APPLICATION MATERIALS TO THE DEPARTMENT OF  
ENVIRONMENTAL QUALITY AND PROVIDING FOR OTHER MATTERS  
IN CONNECTION THEREWITH

WHEREAS, the Parish of St. Tammany, State of Louisiana (the "Parish") is in need of an inspection program for on-site sewage disposal systems throughout the Parish, including but not limited to a program to help homeowners pay for sewer system repairs; and

WHEREAS, loans and/or grants for this project may be available through the Clean Water State Revolving Fund loan program operated by the Louisiana Department of Environmental Quality ("DEQ").

THE PARISH OF ST. TAMMANY HEREBY RESOLVES THAT:

SECTION 1. The Parish President is hereby authorized to submit a pre-application, application, and issue debt in the maximum amount of \$706,825.00 to DEQ on behalf of the Parish for the purpose of placing this project on the Project Priority List for funding through the Clean Water State Revolving Fund loan program.

SECTION 2. The Parish President is further authorized to furnish such additional information as may reasonably be requested in connection with the application materials.

SECTION 3. The Parish President is hereby designated as the Official Project Representative for the Parish for any project that may result from the submission of such materials to DEQ.

SECTION 4. Any materials previously submitted to the Department on behalf of the Parish are hereby ratified and approved.
