## Safe Haven Cardinal Cove Renovations

Scope: Renovation of approximately 11,173 square feet of space to be used as a veterans' housing facility. The facility consists of five cabin buildings and one community space building. The existing space will be upgraded to meet current codes and standards for veteran's housing facilities.

Status: MSH Architects has completed preliminary programming and design work. An RFP will be put out in January of 2024 to begin work on the full design. Budget being reduced due to expired Grant funding.
