ORDINANCE TO REVOKE AN UNOPENED PORTION OF RIGHT-OF-WAY LOCATED ON THE NORTH SIDE OF PONTCHITOLAWA DRIVE SOUTH OF INTERSTATE 12 BETWEEN LOT 6 AND LOT 7 OF THE PONTCHITOLAWA ESTATES SUBDIVISION (AS DELINEATED ON MAP #35C). (WARD 3, DISTRICT 5) (REV23-10-006)

WHEREAS, the petitioner, who owns property abutting the aforementioned Parish street right-of-way, has petitioned the St. Tammany Parish Council to revoke/alienate a portion of the dedication, specifically an unopened portion of right-of-way, located on the north side of Ponchitolawa Drive south of Interstate 12 between Lot 6 and Lot 7 of the Pontchitolawa Estates Subdivision (as delineated on Map #35C) Ward 3, District 5; and

WHEREAS, the Department of Public Works, and Department of Planning & Development have reviewed and researched said request and have reported their findings to the St. Tammany Parish Planning Commission; and

WHEREAS, the St. Tammany Parish Planning Commission, upon review of said petition, and after having considered all of the facts relevant to this request, has concluded that said portion of said street right-of-way is no longer needed for public purposes as defined pursuant to statutory law, and therefore recommends to the Parish Council the adoption of the proposed revocation request.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that it hereby concurs with the findings of the Planning Commission and therefore grants approval of the revocation/alienation request for the portion of the street right-of-way as referred to above, subject to the following:

SECTION I: The petitioners, or any other adjacent property owner who wishes to participate, if any, shall enter into a private cash sale with the Parish to conclude the revocation/alienation process as set forth in St. Tammany Parish Code of Ordinances Section 35-1, and in accordance with the provisions of La. R.S. 48:701, et seq. and/or La. R.S. 48:711, et seq.

SECTION II: The reservation of servitude 10 feet from centerline of 8 inch waterline for a total servitude width of 20 feet.

SECTION III: The reservation of servitude 10 feet from centerline of 8 inch sewerline for a total servitude width of 20 feet.

SECTION IV: The applicant submitting a revised survey to depict and denote both servitude reservations for entire length of unopened right of way.

SECTION V: No structures, buildings, fences, gates and/or similar shall be allowed to remain and/or exist within the servitude areas reserved

SECTION VI: The Department of Utilities shall retain unrestricted access for perpetuity to servitudes with no advance notice required or limitations imposed.

SECTION VII: Following execution of the private cash sale(s), the petitioners shall assimilate the right-of-way into its abutting lots through the Parish's administrative resubdivision process.
