A resolution approving the holding of an election in St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, on Saturday, April 27, 2024, to authorize the renewal of special taxes therein.

WHEREAS, the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), plans to call a special election in the District on Saturday, April 27, 2024, to authorize the renewal of special taxes therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries for further authority to continue to levy the special taxes therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special taxes provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, April 27, 2024, at which election there will be submitted the following propositions, to-wit:

PROPOSITION NO. 1 OF 2  
(MILLAGE RENEWAL)

Shall St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), continue to levy a special tax of 10.12 mills on all property subject to taxation within the District (an estimated \$349,110 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2026 and ending with the year 2035, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment in and for the District, including emergency equipment and supplies, and paying the cost of obtaining water for fire protection purposes and paying charges for fire hydrant rentals and service?

PROPOSITION NO. 2 OF 2  
(MILLAGE RENEWAL)

Shall St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), continue to levy a 10 mills tax on all the property subject to taxation in the District (an estimated \$344,970 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2028 and ending with the year 2037, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment in and for the District, including emergency

equipment and supplies and paying the cost of obtaining water for fire protection purposes and paying charges for fire hydrant rentals and service?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special taxes provided for therein.
