ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 28, ARTICLE III WATERWAYS, DIVISION 2 WATERCRAFT SPEED LIMITS, SECTION 28-121 (A) (16) TO CREATE AN ADDITIONAL DEAD SLOW, NO WAKE ZONE ON AN UNNAMED SLOUGH EAST OF MAGNOLIA FOREST SUBDIVISION, PHASE 7 (WARD 8, DISTRICT 9)				
WHEREAS, in the interest of public safety, health and general welfare, it is necessary to create an additional "Dead Slow, No Wake" zone for an unnamed slough approximately 800' in length and situated immediately east of Magnolia Forest Subdivision, Phase 7 as depicted on the attached map.

TAMMANY HEREBY ORDAINS: that it amends Parish Code of Ordinances, Chapter 28, Article III Waterways, Division 2 Watercraft Speed Limits, Section 28-121(a)(16) Operation; special speed limits; definitions; Unlawful Operation; Pearl River Basin Area to create an additional "Dead Slow, No Wake" zone on an unnamed slough east of Magnolia Forest Subdivision, Phase 7, to be read as follows:				
e. An unnamed slough approximately 800' in length situated immediately east of Magnolia Forest Subdivision, Phase 7 as depicted on the attached map.
