ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 1

**AMENDMENT NO. 1 - 2024 CAPITAL IMPROVEMENTS - JANUARY 2024**

**SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)**

**CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE**

Browns witch Rd. Bridge

Scope: Browns witch Rd bridge is a bridge less than 20 feet in length and, therefore, is not part of the Federal off-system bridge inspection program. The structure is estimated to be over 40 years old. Public Works crews making repairs to a damaged bridge guardrail reported the bridge to be in poor condition with deteriorated pilings in 2023. The Engineering department is recommending replacement of the bridge to prevent future closure of the bridge. Project shall design and construct a bridge replacement for the Browns witch Rd. bridge. Design shall include all engineering design, environmental, geotechnical, and survey services. Construction shall include construction of the bridge, and construction engineering and inspection services.

Status: The Engineering Department will requisition a consultant for preliminary plans when funding is made available. It is anticipated that preliminary plans will be complete by late 2024 and that final plans will be complete in 2025. Construction is anticipated to commence in 2025.
