ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT,
THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO A LEASE
OF OFFICE AREAS LOCATED IN THE TOWERS BUILDING.

WHEREAS, St. Tammany Parish Government owns an office building located at 520 Spanish Trail, Slidell, Louisiana, known as the Towers Building; and

WHEREAS, Northshore Technical Community College desires to lease certain office spaces on the 6th floor of the Towers Building; and

WHEREAS, in accordance with St. Tammany Parish Government Home Rule Charter Sec. 2-11A (11), lease of real property owned by the Parish shall be approved by ordinance.

ST. TAMMANY PARISH GOVERNMENT HEREBY ORDAINS: that the Office of the Parish President is authorized to exercise its discretion in entering into an agreement to lease certain office space areas on the 6th floor of the Towers Building, located at 520 Old Spanish Trail, Slidell, Louisiana, to Northshore Technical Community College, together with all documents and transactions necessary to carry out the intent of this Ordinance.

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon adoption.
