ORDINANCE TO AMEND THE 2026 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 12
COASTAL RESTORATION CAPITAL PROJECTS

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Northshore Living Shorelines

Scope: Project will develop a living shoreline along the Lake Pontchartrain coastline, near Goose Point. Project will include wave attenuation features that will provide a suitable habitat for local fauna.

Status: Construction is estimated to begin in Fall 2026.

Fritchie Marsh-Old Spanish Trail Water Control

Scope: Project to include design, permitting, and land acquisition for a water control structure located at Old Spanish Trail (LA433). Additionally, project will include survey, geotechnical investigation, alternative analysis, cost estimating, stakeholder coordination, and preparation of construction bid documents. Based on modeling results, completed under the Fritchie Marsh-Salt Bayou project, a scope was revised to emphasize hydrologic and hydraulic restoration of the surrounding channels.

Status: Project is estimated to be completed approximately 15 months from the Notice to Proceed.
