ORDINANCE TO AMEND PART I – CODE OF ORDINANCES, CHAPTER
40 – UTILITIES, ARTICLE IX. – ENVIRONMENTAL UTILITY SERVICE
AGREEMENTS, TO ADD SEC. 40-267. – REQUIRED NOTICES.

WHEREAS, a number of private utility companies have been granted franchises to provide water and sewerage services in the unincorporated portions of St. Tammany Parish; and

WHEREAS, St. Tammany Parish Government is responsible for the monitoring, enforcement, and supervision of all existing and future franchise agreements relative to sewerage and water systems within the unincorporated portion of St. Tammany Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that St. Tammany Parish Code of Ordinance, Part I – Code of Ordinances, Chapter 40 – Utilities, Article IX. – Environmental Utility Service Agreements is hereby amended to add Sec. 40-267. – Required Notices, as follows:

Sec. 40-267. – Required Notices.

Any party granted a franchise for the provision of water and sewerage services in unincorporated St. Tammany Parish, whether in an environmental utility service agreement or otherwise, shall provide at least thirty (30) days advanced notice to St. Tammany Parish Government of its intent to market and sell any community water supply distribution system or sewerage collection and treatment system owned by it. Said notice shall be delivered via certified mail to the attention of the Parish President.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared severable.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption.
