ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE CERTAIN PARCELS, RIGHTS-OF-WAY, AND/OR SERVITUDES FOR DRAINAGE IMPROVEMENTS IN THE WOODLANDS SUBDIVISION.

WHEREAS, St. Tammany Parish Government desires to acquire a certain drainage servitude in The Woodlands subdivision as depicted and identified in the Drainage Servitude Agreement and plat hereto (collectively, the “Drainage Servitude”); and

WHEREAS, there is a need and public purpose for the acquisition of the Drainage Servitude, which will serve to improve the drainage of surface water in the subdivision and surrounding areas; and

WHEREAS, The Woodlands Property Owners Associations will donate the Drainage Servitude to the Parish, and Parish President is authorized to do whatever is necessary to acquire the donated Drainage Servitude.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire by donation from The Woodlands Property Owners Association a 30’ Drainage and Access Servitude identified in the attached Drainage Servitude Agreement and as depicted on the plat attached hereto (collectively, the “Drainage Servitude”); and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in acquiring the Drainage Servitude, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon adoption.
