SECTION II: CAPITAL IMPROVEMENTS - FACILITIES

Justice Center MTI System

Scope: The existing MTI Security Control System at the Justice Center is obsolescent and in need of replacement/upgrading. The system controls the jail and secure holding area doors, prisoner transport elevators, and duress security system. The existing hardware can no longer be repaired or replaced.

Proactive upgrading of the existing system will prevent failure of the MTI system. Additionally, upgrading the existing system will allow for integration of the security camera system, increasing site security, and decreasing security response time.

Status: Project has already been out to bid and will be completed within six months, once additional funds are secured. Amendment is being requested due to the bid price received exceeding current budget.
