	ORDINANCE TO AMEND CAPITAL FUND 252-24XX DEEP WATER RENOVATIONS TO REDUCE THE BUD	HORIZON EOC BUILDING	
WHEREAS, the 2023 Capital Improvements – Facilities budget proposed by the Administration in September of 2022 included a line item for EOC Building Renovations in the amount of seven million two hundred thousand dollars (\$7,200,000.00) budgeted out of the Deep Water Horizon Fund – 252-24XX; and			
WHEREAS, the Parish Council amended the proposed budget to reduce this line item by seven million one hundred thousand dollars (\$7,100,000.00), leaving one hundred thousand dollars (\$100,000.00) in the budget with the stated purpose for said funding of performing a feasibility study for potential uses and costs of renovating the EOC Building located in downtown Covington; and			
WHEREAS, the funds have not been utilized and the Administration has not moved forward with hiring a consultant to review the feasibility, including cost, of utilizing the building as an EOC.			
THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in accordance with the above and foregoing, the Capital Improvements Budget – Facilities Fund 252-24XX Deep Water Horizon EOC Building Renovations line item is hereby reduced by one hundred thousand dollars (\$100,000.00), funding to be returned to the originating Fund.
