ORDINANCE TO AMEND THE 2023 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 36

Scope: St. Tammany Parish Government shall fund \$325,000 toward construction of drainage improvements of a drainage ditch located in between Rosedown subdivision and Meadowbrook subdivision. Sub-drainage District No. 2 of Gravity Drainage District No. 5 shall design, contract, and manage construction of said improvements.
