TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A GRANT APPLICATION FOR FUNDING OF THE GOODBEE WASTEWATER TREATMENT PLANT EXPANSION (WARD 1, DISTRICT 3)

WHEREAS, St. Tammany Parish Government is in need of funding to expand the Goodbee Wastewater Treatment Plant; and

WHEREAS, loans and/or grants for this project may be available through the Clean Water State Revolving Fund loan program operated by the Louisiana Department of Environmental Quality.

TAMMANY HEREBY RESOLVES: that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to submit a pre-application and/or application to the Louisiana Department of Environmental Quality for funding through the Clean Water State Revolving Fund loan program benefitting expansion of the Goodbee Wastewater Treatment Plant and to take any and all actions necessary to submit a pre-application and/or application in support of same.
