ORDINANCE ESTABLISHING ADJUSTED MILLAGE RATES FOR THE YEAR 2023.

WHEREAS, the Home Rule Charter for St. Tammany Parish Section 2-11 (3) requires an ordinance to levy taxes, assessments and charges.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on <u>July 6</u>, <u>2023</u>, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following adjusted millage rates be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2023, for the purpose of raising revenue:
