LA3241 Corridor Traffic Analysis

Scope: St. Tammany Parish is preparing a land use and transportation study for the area along the LA Highway 3241 corridor. The LA Highway 435 corridor to be reviewed is approximately 20 miles between I-12 and Bush. The capacity projects are being implemented in phases and the Parish should develop highway related strategies and corridor planning accommodating forecasted growth in the area. The need for the analysis results from construction of a new state highway that will result in population growth and development in this area of St. Tammany. The LA Highway 3241 project will provide an alternative north-south connection that will reduce congestion and delays for those traveling from northern St. Tammany Parish and Washington Parish to I-12. The proposed highway would increase safety by reducing the amount of traffic and congestion on existing routes (LA41 and LA21/LA59/US190). However, the opening of a new roadway will open up land for development, and access management and corridor planning are needed.

Status: Study timeline is 12 months.
