RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT REGARDING THE MODIFICATION OF STATE HIGHWAY I-10 / US 190 GAUSE (WARD 8, DISTRICTS 8, 13, 14)

WHEREAS, the Parish seeks to construct or have constructed intersection improvements along the intersection of US 190 Gause Blvd. and Interstate 10 owned by the State of Louisiana, Department of Transportation and Development (“DOTD”); and

WHEREAS, DOTD is willing to allow Parish to undertake the design and construction of improvements pursuant to the terms Cooperative Endeavor Agreement to be executed.

THE PARISH COUNCIL OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development, for construction of intersection improvements to US 190 Gause Blvd and Interstate 10 and to take any and all actions necessary to enter into the Cooperative Endeavor Agreement in support of same.
