COASTAL RESTORATION CAPITAL PROJECTS

AMENDMENT NO. 11 - 2025 CAPITAL IMPROVEMENTS - APRIL 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Northshore Living Shorelines

Scope: The Northshore Living Shorelines project aims to mitigate coastal erosion and foster habitat restoration in the Goose Point area, located just below the Big Branch National Wildlife Refuge in St. Tammany Parish. This region has been experiencing accelerated shoreline degradation, with multiple breaches already impacting the marshlands. These breaches exacerbate land loss and threaten the ecological integrity of the area.

The living shoreline will help slow erosion, stabilize the marsh edge, and reduce breaches that allow saltwater intrusion into freshwater wetlands. The project will also mitigate storm surges, thereby reducing flood risks for coastal communities and critical infrastructure, and will act as a protective barrier for anticipated marsh creation projects in the area.

Phase 1 focuses on designing and constructing approximately 1,915 linear feet of living shoreline using rubble mound breakwaters. Phase 2 includes engineering and construction of an additional 505 linear feet of living shoreline. As funding opportunities arise, subsequent phases will extend protection to the entire 2.5-mile coastline, ensuring comprehensive shoreline defense.

Status: Feasibility and Phase 1 design are complete. Permitting has been submitted for Phases 1 and 2, and construction is estimated to begin Fall 2025. Anticipated completion of Phases 1 and 2 is Spring of 2026.
