ORDINANCE TO CHANGE A PORTION OF S. PONTCHARTRAIN DR. (EAST AND WEST PORTION) (R07F001) TO ST. LOUIS ST. (R07G011) AS PER THE ATTACHED 911 RECOMMENDATION. THIS PORTION IS WEST FROM S. 24^{TH} ST. (R07F010) FOR 6,300 FT. (WARD 7, DISTRICT 7)
