SECTION II: CAPITAL IMPROVEMENTS - FACILITIES

Animal Services Generator

Scope: Costs include the labor and material of remaining project items as the generator has been purchased and delivered, and is being housed at N. Tyler St. while the installation quote is being considered. Purchase and installation of the fuel and fuel tank, cement pad support, and other installation items still need to be completed, as well as the transport and delivery from N. Tyler St. to the Animal Services Complex. Anticipate to complete the installation prior to the beginning of hurricane season, as this generator will greatly help to continue operational success of housing 250-300 animals routinely, even during extended power outages.

Status: Additional funding needed to haul and install generator and complete slab construction. Construction could begin as early as April/May 2025.
