WHEREAS, as part of Other Conditions, Section H. of LPDES permit LA0120235, the Parish Government must complete an annual Environmental Audit Report for the life of the permit, and said Environmental Audit Report is attached hereto.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the St. Tammany Parish Council acknowledges the receipt of the 2024 Municipal Water Pollution Prevention Environmental Audit Report for the West St. Tammany sewage Treatment Facility and its finding that improvements to lift stations in the collection system are undergoing upgrades and/or replacements.
