RESOLUTION SELECTING A NEWSPAPER AS THE PARISH OFFICIAL JOURNAL PURSUANT TO THE PROVISIONS OF LOUISIANA REVISED STATUTES 43:140 ET. SEQ. (BID NO. 25-14-2)

WHEREAS, pursuant to the applicable requirements of La. R.S. 43:140 through 43:181, the Parish Council had noticed a solicitation to parish newspapers for bid to be the Parish Official Journal for the period July 1, 2025 through June 30, 2026; and

WHEREAS, after receiving bids within the time allowed by law and identifying the lowest bidder, the Parish Council determines to make selections for the Parish Official Journal.

THE PARISH COUNCIL OF ST. TAMMANY HEREBY RESOLVES, by the St. Tammany Parish Council as the governing authority, that it hereby accepts the recommendations of the Department of Procurement to accept the lowest bid received and approves the St. Tammany Farmer as the Parish Official Journal for the period of July 1, 2025 through June 30, 2026.

BE IT FURTHER RESOLVED that the rate to be paid by the Parish to its Official Journal shall not exceed Three Dollars and ninety-two Cents (\$3.92) per column inch during the period stated herein.
