RESOLUTION TO ACKNOWLEDGE THE RECEIPT AND REVIEW OF THE
2024 MUNICIPAL WATER POLLUTION PREVENTION
ENVIRONMENTAL AUDIT REPORT FOR THE WADSWORTH SEWAGE
TREATMENT FACILITY (WARD 4, DISTRICT 11)

WHEREAS, the St. Tammany Parish Government owns and operates the Wadsworth Sewage Treatment Facility; and

WHEREAS, the Louisiana Pollutant Discharge Elimination System (LPDES) permit which authorizes effluent discharge from the Wadsworth Sewage Treatment Facility mandates the Parish to institute a program directed towards pollution prevention in order to improve operating efficiency and extend the useful life of the treatment facility; and

WHEREAS, as part of Other Conditions, Section H. of LPDES permit LA0124214, the Parish Government must complete an annual Environmental Audit Report for the life of the permit, and said Environmental Audit Report is attached hereto.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the St. Tammany Parish Council acknowledges the receipt of the 2024 Municipal Water Pollution Prevention Environmental Audit Report for the Wadsworth Sewage Treatment Facility and its finding that no actions are necessary at this time for compliance achievement, that no flows are presently received by the plant but area is currently under development, and planning is underway for addition of a 30,000gpd plant.
