Administrative Comment Amendment No. 10 - 2025 Operating Budget - June 2025

This budget amendment is to:

a. 101 - DRAINAGE MAINTENANCE FUND

FUNDING SOURCE: AD VALOREM TAX

To amend the beginning fund balance by \$2,520,580.46 from ad valorem transferred to operating due to capital projects closed in fiscal year 2024.

To amend the budget by \$984,500.00 to transfer funds to the LA59 Area Drainage Property project, to purchase 168.69 acres of land for a possible pond location as well as drainage conservation of land in a Critical Drainage Area. The total project budget is \$1,774,500.00.

b. 121 - HWY 21 ECONOMIC DEVELOPMENT FUND (FORMERLY EDD SUB-FUND 123-2025)
