Wetlands Plan, Ph.3

Scope: The purpose of this project is to develop an assortment of community-based meetings to inform and educate St. Tammany residents, stakeholders, and decision-makers on the portfolio of wetlands and drainage data and mapping from previous phases. The community-based meetings will solicit feedback from citizens, stakeholders, and other organizations to provide the Parish Administration, Council, Commissions, and staff with recommendations for protecting valuable wetlands, mitigating property damage due to flooding, and improving overall water quality and drainage flow.
