AMENDMENT NO. 28 - 2025 CAPITAL IMPROVEMENTS - NOVEMBER 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Carr Dr. Hydrology Restoration

Scope: The continuation of the Carr Drive Hydrology Restoration Project will involve the following key activities:

- Dredging and Restoration of Drainage Canal: Mechanical dredging of a critical drainage canal south of Carr Drive to restore flow capacity and reduce flooding risks.
- Beneficial Use of Dredged Material: Placement of dredged spoil in adjacent degraded marsh areas to promote marsh creation and restoration.
- Habitat Enhancement: The project will improve aquatic habitat for fisheries and increase ecological productivity in the area.
- Coastal Resilience: Enhancements will contribute to wave erosion protection and long-term resilience of the surrounding community and infrastructure.
- Permitting and Compliance: All work will comply with federal, state, and local environmental regulations, including securing any necessary permits.

Status: This amendment is being requested to complete project construction.

Program Management, Ph.2

Scope: To succeed, the Parish must coordinate with CPRA, align with the State's Coastal Master Plan, engage the Legislature for funding and approvals, and support the Levee Board in meeting local obligations. Additional funding is needed for state and local program management to complement federal efforts by ensuring projects are state-aligned, local managed, and community-supported.

The CSFRM project and local flood protection efforts will reduce storm surge risk, protect homes and infrastructure, restore wetlands, strengthen levees, and improve community resilience. These investments safeguard lives, lower disaster recovery costs, and support long-term sustainability for St. Tammany Parish.

Status: Project is estimated to take 12 months to complete.
