SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Bayou Liberty Land Use Study

Scope: Complete Bayou Liberty Land Use Study, including land use, regulatory, and mapping analysis that advances more resilient residential housing construction and land use strategies in the Parish. Anticipated tasks include:

- Review of flood risk data submitted by stakeholders and already existing for each site.
- Documentation of reasons to amend proposed map for each site and the study area more broadly.
- Stakeholder meetings.
- Adoption and transition support.
- Amendments to GIS map layer.
- Production of site-by-site map insets showing flood risk data and topography.

Status: Estimated timeframe is six months.
