ORDINANCE TO REMOVE A PORTION OF HARBOR DR. (R09J030) FROM ST. TAMMANY PARISH SELECTIVE MAINTENANCE SYSTEM (WARD 9, DISTRICT 13)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically for the corrections/additions/deletions to the road and drainage inventories based upon the recommendations of the Department of Engineering, Director of Public Works, 911 Facilitator; and

WHEREAS, the property owners have petitioned for this road closure; and

WHEREAS, 1,170 ft. of Harbor Dr. shall be closed and considered unopened ROW; and

WHEREAS, the property owners shall be required to complete the “enter the parish right of way” process prior to the issuance of a building permit for property that abuts the unopened row on Harbor Dr.; and

WHEREAS, the parish maintenance will end at approximately station 2,385 ft.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System is amended as follows:

- 1. Remove a portion of Harbor Dr. (R09J030) – remove 1,170 ft.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

PURPOSE: To remove a portion of Harbor Dr. (R09J030) from St. Tammany Parish Selective Maintenance System in District 13. The property owners have petitioned for this road closure. 1,170 ft. shall be closed and considered unopened ROW. Property owner shall be required to complete the Enter the Parish ROW process prior to the issuance of a building permit for property that abutts the unopened ROW on Harbor Dr. The parish maintenance will end at approximately 2,385 ft. (Ward 9, District 13). Therefore, the Department of Public Works recommends adoption.
