DPW Fence Repairs-Hurricane Ida

Allocate available funds to repair fencing damaged by by Hurricane Ida located at Hickory Barn, Covington Barn, Camp Salmen, and along Emerald Forest Blvd. Total project funding is \$200,000 as follows: \$19,000 from Capital Projects fund 200-4605 - Sales Tax District 3 - General Maintenance, \$1,000 from Capital Projects fund 252-2423 Buildings - General - Camp Salmen Facilities, and \$180,000 from FEMA.
