ORDINANCE TO AUTHORIZE THE EXECUTION OF AN AMENDMENT TO THE EXISTING AMBULANCE SERVICE AGREEMENT PURSUANT TO LA. R.S. 33:4791.1 BETWEEN ST. TAMMANY PARISH GOVERNMENT AND ACADIAN AMBULANCE SERVICE, INC. FOR THE PROVISION OF EMERGENCY AND NON-EMERGENCY AMBULANCE SERVICES WITHIN SPECIFIC SERVICE AREAS OF ST. TAMMANY PARISH.

WHEREAS, on December 4, 2014, St. Tammany Parish Government entered into a Contract for Emergency and Non-Emergency Ambulance Services for the Parish of St. Tammany and Including Any Municipality Choosing to Participate via Intergovernmental Agreement (“Agreement”) with Acadian Ambulance Service, Inc. (“Acadian”) to provide emergency and non-emergency medical transportation services within specific service areas of St. Tammany Parish; and

WHEREAS, said Agreement was last extended on January 29, 2019 for a period of four years; and

WHEREAS, the Quality Assurance Panel at their meeting on June 29, 2022 recommended an amendment to the Agreement relative to staffing requirements for emergency and non-emergency transportation services; and

WHEREAS, the recommended amendments meet or exceed all local, state, and federal requirements.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it adopts the amendment to the Ambulance Service Agreement and authorizes the Parish President and Parish Council Chairman to execute said Agreement and Intergovernmental Agreements as may be necessary.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
