An ordinance accepting the finalized subdivisions into the Road and Drainage Inventories, specifically Simpson Farms Subdivision Phase 1 (Ward 3, District).

WHEREAS, Developer/Owner(s) have dedicated the rights of way to the public as indicated on the finalized subdivision plat recorded in the Clerk of Court's office.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that all area within rights of way, the road base, surface drainage ditches, culverts, laterals, canals and appurtenances thereunto belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolution/Ordinance stated shall be incorporated in the Parish Maintenance System.

BE IT FURTHER ORDAINED: that all parish regulations, policies, procedures and operating methods pertaining to the Parish Selective Road Maintenance System:

Streets to be accepted into the maintenance system are:

Turf Dr. (R03D067) for 1,733 ft.
Grassy Lane (R03D068) for 1,445 ft.
Sod Way (R03D069) for 400 ft.
Turf Dr. Lateral (D03DW01062) for 400 ft.
Simpson Farms pond #1 (P03DW01062)
Simpson Farms pond #2 (P03DW02062)

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
