ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES, PART I – CODE OF ORDINANCES, CHAPTER 30 – PARKS, RECREATION AND SCENIC NEIGHBORHOODS, ARTICLE V. – RECREATION DISTRICT NO. 4, SEC. 30-120 – CREATED; BOUNDARIES; GOVERNING BOARD; TO CHANGE THE BOUNDARIES OF RECREATION DISTRICT NO. 4.

WHEREAS, St. Tammany Parish Recreation District No. 4 was created in 1981 to encourage recreation and promote the general health and well-being of youths in the district; and,

WHEREAS, the original boundaries of Recreation District No. 4 when the District was created were described as the entirety of the 7th Ward of the Parish as it existed on May 5, 1977; and,

WHEREAS, in 2015, the boundaries of Recreation District No. 4 were amended to exclude portions of Council District 11 within Ward 7 pursuant to Ordinance Council Series No. 15-3396 in order to accommodate the requests of some residents in Council District 11; and,

WHEREAS, the Council seeks to revise the boundaries of Recreation District No. 4 to restore portions of the 7th Ward which were included in the District's original boundaries, as reflected in the map attached as Exhibit "A" and as further described below.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that St. Tammany Parish Code of Ordinances, Part I – Code of Ordinances, Chapter 30 – Parks, Recreation, and Scenic Neighborhoods, Article V – Recreation District No. 4, Sec. 30-120 – Created; boundaries; governing board, be amended to change the boundaries as reflected below:

Sec. 30-120. Created; boundaries; governing board.

There is hereby created St. Tammany Parish Recreation District No. 4, the boundaries of which shall be the entire 7th Ward of the parish as it existed on May 5, 1977, excluding that portion included in the boundaries of Council District 11 as they exist on August 6, 2015, less and except those parcels identified on the map attached hereto as Exhibit "A."

Said boundaries of Recreation District No. 4 shall be further described as follows:

Legal Description

A certain parcel of ground comprised of a portion of Sections 8 & 9, T8S, R13 E, Greensburg District, St. Tammany Parish, Louisiana, being more particularly described as follows:

Commence at the section corner common to Sections 4, 5, 8, and 9, T8S, R13E and go in a southerly direction along the section line common to sections Section 8 and 9 for a distance of 1,324 feet to a point at the SW corner of the NW quarter of the NW quarter of Section 9, T8S, R13E, said point being the POINT OF BEGINNING.

Thence proceed in a southerly direction along said section line for a distance of 1,300.46 feet to a point at the quarter corner common to Sections 8 & 9, T8S, R13E; thence

Proceed in an easterly direction for a distance of approximately 2,647.24 feet to a point at the NE corner of the SW quarter of Section 9, T8S, R13E; thence

Proceed in a southerly direction for a distance of approximately 2,646.43 feet to a point at the SE corner of the SW quarter of Section 9, T8S, R13E; thence

Proceed in a westerly direction along the section line common to Sections 9 & 16, T8S, R13E for a distance of approximately 2,638.77 feet to a point at the section corner common to sections 8, 9, 16, & 17, T8S, R13E; thence

Proceed in a westerly direction along the section line common to sections 8 & 17, T8S, R13E for a distance of approximately 3,455.49 feet to a point at the intersection of said section line and the easterly right-of-way line of Louisiana Highway 434; thence

Proceed in a northeasterly direction along the easterly right-of-way line of Louisiana Highway 434 for a distance of approximately of 4,592 feet to a point; thence

Proceed in an easterly direction for a distance of approximately 1,081.52 feet to a point, said point being the Point of Beginning.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
