## **Ordinance Administrative Comment**

Parish acquired the 0.14-acre parcel from the St. Tammany Parish Development District. Parcel was originally intended for intersection improvements at La 1085 and Diversified, which are determined to be no longer necessary and/or no longer in need of subject parcel. Proposed sale for the site at this time is at private sale for appraised value to the adjoining owner.
