ORDINANCE TO AMEND THE EFFECTIVE DATE OF ST. TAMMANY PARISH ORDINANCE COUNCIL SERIES NO. 23-5339 RELATIVE TO THE RENAMING AND REORGANIZATION OF THE ST. TAMMANY PARISH CODE OF ORDINANCES PART II: UNIFIED DEVELOPMENT CODE (PARISHWIDE).

WHEREAS, on December 18, 2023, the St. Tammany Parish Council adopted Ordinance Cal. No. 7465, which was identified as Ordinance Council Series No. 23-5339 after its adoption, and which was entitled "Ordinance to rename and reorganize existing Part II – Land Development Code (LDC) of the St. Tammany Parish Code of Ordinances to re-establish Part II as a Unified Development Code (UDC), update standards within and across Part II: Unified Development Code, and to streamline, simplify and improve overall Code navigation"; and

WHEREAS, Ordinance Council Series No. 23-5339 as adopted is slated to become effective on July 1, 2024; and

WHEREAS, the extended implementation period of the reorganized Unified Development Code was intended to allow the Parish Council and Parish Administration time to review and amend codal provisions as necessary prior to the July 1, 2024 effective date; and

WHEREAS, the Parish Council and Parish Administration have identified multiple provisions of the reorganized Unified Development Code that may need to be amended and additional time is necessary;

WHEREAS, a new effective date of August 2, 2024 for the reorganized Unified Development Code will allow the Parish Council sufficient time to review and consider such proposed amendments.

NOW, THEREFORE, THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Parish Council Series No. 23-5339 be amended to reflect a revised effective date of August 2, 2024.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
