RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE MEMORANDUM OF UNDERSTANDING WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT AND NORTHPOINTE BUSINESS PARK, LLC FOR IMPROVEMENTS TO LA 1085 NEAR LA 1077 (WARD 1, DISTRICT 3)

WHEREAS, the State of Louisiana, Department of Transportation and Development (“DOTD”) seeks to construct or have constructed improvements to La 1085 (Bootlegger Rd) near/at the intersection with La 1077 in order to facilitate further development of Northpointe Business Park Subdivision and general traffic improvements in the area; and

WHEREAS, St. Tammany Parish Government desires that DOTD undertake the improvements to improve traffic flows and road betterments in general, as well as to facilitate further development of Northpointe Business Park Subdivision.

THE PARISH COUNCIL OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into an Memorandum of Understanding, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development and Northpointe Business Park, LLC, for DOTD’s construction of improvements to La 1085 and to take any and all actions necessary to enter into the MOU in support of same.
