Library Technical & Maintenance Building-Elevator

Scope: Addition of a new passenger elevator to the St. Tammany Parish Library Technical Services and Maintenance Building. The new passenger lift will be installed in the warehouse and will provide access to the second floor IT and office space.

Status: Project is currently working toward final design plans. The St. Tammany Parish Library Board of Control adopted a Resolution on March 25, 2024 to increase the budget for construction and installation of the elevator. Final plans expected mid-2024, with construction expected late 2024.
