F2308    HUD-Entitlement FY23

Grant award received to develop viable urban communities by providing decent housing, a suitable living environment, and expanding economic opportunities, principally for persons of low and moderate income.

**146 - GRANTS-OHSEP**

F2307    DHH-48 Hour Mass Antibiotic Dispensing Program FY23

Grant award received for emergency management personnel costs in relation to the Cities Readiness Initiative to incorporate capabilities to provide medications to 100% of the designated population in less than 48 hours.

**148 - GRANTS-TRANSPORATION**

S2307    DOTD-General Aviation Maintenance Program FY21

Grant award received for airport maintenance costs. Grant will fund 50% of eligible expenditures, and the General Fund will match the remaining 50%.
