Carr Dr. Hydrology Restoration

Scope: The next phase of the project will include engineering work needed to support the design & bidding services required to prepare for construction. The construction phase will consist of dredging the canal to restore drainage and will provide use of dredged spoil for an adjoining marsh creation project. Future protection of wave erosion, additional fisheries habitat, and coastal resilience for the Slidell community will also be a benefit of the project.

Status: A vendor was previously procured to perform a feasibility study, which supports the benefits of this project. The design phase will take approximately 12 months to complete.
